JOB TITLE: Caregiver

POSITION TYPE: Part-Time

REPORTS TO: Member of Management Team

Job Purpose:

Provide courteous and responsive care to elderly and/or disabled clients.

Essential Duties:

- Assist client with bathing
- Assist client with personal care (oral, hair, etc)
- Assist client with toileting and/or incontinence care
- Assist client in transferring in/out of bed or wheelchair
- Assist client with dressing/undressing
- Preparation of meals
- Assist client with feeding
- Change bed linens
- Performing light housekeeping (including laundry, dusting, general cleaning)
- Medication reminders
- Comply with Sandata policies including scheduled times

Skills/Qualifications:

- Excellent communication skills, ability to deal with patients at all levels.
- Strong attention to detail and good interpersonal skills.
- Strong decision making and problem solving skills.
- Ability to multi-task in fast-paced dynamic environment.
- Ability to read, understand, and follow directions and interpret material
- Must be able to effectively communicate with employees and clients
- Ability to lift up to 25 pounds
- American Red Cross Adult CPR / First Aid Certified.

Requirements:

KNOWLEDGE – Requires the ability to perform basic math such as adding, subtracting, multiplying, and dividing, the ability to speak, read and write coherently.

MENTAL – Requires a high concentration while multi-tasking projects, maintain great organizational skills, communicating with other employees and clients. Must have hand, eye and foot coordination.

PHYSICAL - May require duties involving sitting, stooping, or bending for up to eight hours daily and the ability to lift up to 40 lbs.

MANUAL DEXTERITY - Requires use of hands, arms, and feet for lifting up to 40 lbs.

LANGUAGE SKILLS- Must possess language skills sufficient to read and understand instructions, prepare and maintain written reports and records, and communicate with the service recipient.

AUDIBLE - Requires the ability to hear alarms, telephone and verbal communication with clients.

VISUAL - Requires the ability to visually read written instructions.

TESTING- Tuberculosis test must be completed within 30 days of employees hire date unless proof of testing within 12 months can be provided.
